  - prepared original materials and taught first international/comparative environmental law courses at VLS

- 1990s · U.S. and global environmental issues seminars for U.S. federal judges and in Micronesia and Europe
- keynote speaker – first environmental law conference in Madagascar
- 2000s · helped establish Environmental Law Center at Petrozavodsk State University, Russia
- consultant to World Bank – judicial reform and environmental issues focusing on global environmental issues such as sustainable development and land conservation
- 2010s · consultant to electric utility company with respect to merger/acquisition of another electric utility
- consultant to cities in Okinawa, Japan concerning environmental issues involving U.S. Military bases
