SES Position. Provided executive leadership to EPA's clean water discharge program, wastewater infrastructure funding programs, and WaterSense program. SES position. Assisted in overseeing EPA's civil enforcement program under all major environmental statutes except CERCLA. Managed office of nearly 150 attorneys, engineers, and other professionals and budget of over \$24 million with goal of ensuring environmental compliance and protection of public health and the environment. Accomplishments include: designing and overseeing office reorganization to improve efficiency of waste and chemical enforcement, assisting in significant redesign of enforcement program strategic planning structure and performance measures, successfully negotiating new hazardous waste enforcement rules and policies, advising province of Ontario on development of civil penalty system for environmental violations. Also served as Acting Director of the Office from October 2008 to January 2009.

Acting Director, Toxic Release Inventory Program Division. August 2003 to December 2003. Managed EPA's Toxic Release Inventory (TRI) program. The TRI program collects 80,000 reports from nearly 25,000 industrial facilities annually. These reports contain data on hundreds of millions of pounds of toxic chemical releases, data which EPA summarizes and provides to the public in both hard copy and electronic format. Oversaw development of options for reducing regulatory reporting burden, implementation of new approach for accelerated public release of TRI information.

Assistant General Counsel, Office of General Counsel. January, 1997 to August 2003. Led team of 15 attorneys and staff responsible for counseling and litigation on issues arising under the Clean Water Act and Safe Drinking Water Act. Advised government of Trinidad and Tobago and local governments in Latin America on water quality regulation and enforcement. Recipient, General Counsel Award for Managerial Excellence, 2001. Attorney, Office of General Counsel. September, 1987, to January, 1997. Counseled EPA staff and management on legal defensibility of planned regulatory actions under the air, water, and waste statutes.
